OFFICE MEMORANDUM

Subject: Submission of Immovable Property Return for the year 2020 (as on 31.12.2020) by Dy. CLCs(C)/RLCs(C)/ALCs(C)/LEOs(C) et. Of CLC(C) organization.

The undersigned is directed to say that as per DoPT's instruction issued from time to time on the subject mentioned above and under Rule 18 of CCS(Conduct) Rules, 1964, all officers and staff are required to furnish the AIPR in respect of a calendar year by 31st January of the following year. Accordingly, the AIPR for the year 2020 is required to be furnished by 31.01.2021 in the prescribed format and mode by all officers/officials (in Headquarters and field formations) under the charge of this office.

2. In pursuance of the above requirement, all Group-A officers of CLC(C) Organization are requested submit their AIPR for the year 2020(as on 31.12.2020) latest by 31.01.2021 to the Ministry under intimation to this office. In case of late submission/non submission of AIPR, may lead to denial of vigilance clearance for empanelment, deputations, applying to sensitive posts and assignment to training programme (except mandatory training) or as required as the IPR status needs to be checked or the said purposes.

3. Regarding AIPRs in respect of LEOs(C)/OS, the same may please be furnished by all concerned to this office through their Regional Heads, within the stipulated time. In respect of other subordinate staff, it may be submitted at regional levels.


OFFICE MEMORANDUM

Subject :- Submission of Immovable Property Return for the year 2020 (as on 31.12.2020) in respect of all CLS Gr.-"A" Officers - reg.

In terms of Rule 18 of CCS (Conduct) Rules, 1964, the Immovable Property Return (IPR) for the year 2020 (as on 31.12.2020) is required to be furnished by the CLS Officers latest by 31.01.2021. Non-submission of the AIPR within the stipulated time period would invite denial of vigilance clearance to the CLS Officers for empanelment, deputations and cadre clearance applying to sensitive post etc.

2. Therefore, all CLS Gr.-"A" Officers should file their AIPR for the year 2020 (as on 31.12.2020) to CLS (Vig.) Section well in time latest by 31.01.2021 positively for vigilance record. IPRs received beyond the stipulated date shall not be regarded as conforming to the extant guidelines.
